## Safeguarding and Child Protection

The “**Munro Review of Child Protection: A child centred system**”, set out the important role that Local Safeguarding Children Boards have in monitoring how professionals and services are working together to safeguard and promote the welfare of children. It recognised that they are key to identifying emerging problems, through learning from practice and overseeing efforts to improve services .

In its response, the Government has been clear that LSCBs are seen as having a vital role within the local accountability system for child protection.

The Government strongly agrees that LSCBs are a fundamental aspect of local multi-agency arrangements to help and protect children and young people. They occupy a central position in being able to assess the effectiveness of local help and protective services, and it is important that this role is strengthened.

### How C4EO can help

- Facilitating training events for Board members to meet local needs, including action learning sets, local or regional workshops/conferences or the development of training through on-line webinars.
